Ms. Yandow made a motion to adjourn at 6:22 pm, seconded by Mr. Beliveau. Motion carried.

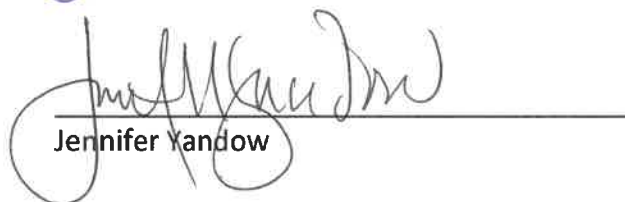
