

Pursuant to the authority granted the Selectmen of the Town of Swanton by 23 V.S.A Sections 1007 and 1008 and 24 V.S.A. Section 1971 et seq., the Selectmen of the Town of Swanton hereby amend the following Stop Sign Ordinance.

“STOP SIGN ORDINANCE” (AMENDED)

Except when directed to proceed by an enforcement officer, as defined by 23 V.S.A. Sections 4(11), every driver of a vehicle approaching a stop intersection indicated by any stop sign below described shall stop at a clearly marked stop line, if any, or none, at the point nearest the intersecting roadway where the driver has a view of approaching traffic on the roadway before entering the intersection. After having stopped, said driver shall yield the right of way to any vehicle which is approaching so closely on said highway as to constitute an immediate hazard during the time when such driver is moving across or within the intersection. The aforementioned stop signs shall be located on the following Town Roads at the following intersections:

This amended ordinance is hereby entered into the minutes of the Selectmen of the Town of Swanton and shall be posted in at least five conspicuous places within the Town of Swanton. Furthermore, a summary of it shall be published in the St. Albans Messenger, within fourteen days of this date of adoption.

Unless a petition is filed pursuant to 24 V.S.A. Section 1973 is filed, this amended ordinance shall become effective sixty days after this date of adoption. If such petition is filed, this amended ordinance shall become effective at the conclusion of the meeting called for that purpose.






