Mr. Cava read through the proposed bylaw revisions with space left between points to discuss the proposed revisions and allow members of the Planning Commission to ask questions. Some of the bylaw revisions included:

- Changes to front, rear, and side setback requirements
- Revising the verbiage of variances to clarify why a project applicant seeking a variance may be denied
- Changes to driveway accesses and road frontages to conform with existing road construction standards
- Revising the definition of accessory dwelling units
- Taking a closer look at flood hazard zone triggers and how this impacts DRB decision-making
- Modifying how existing districts are zoned

Mr. LaBarge expanded upon these points and explained how the DRB has had to undertake quasi-judicial decision-making to conform DRB applicants with the existing bylaw regulations. DRB's decision-making more efficient and would closely align Swanton's standards with the State of Vermont's standards for development.

Mr. Daniel reminded members of the Planning Commission that Gretta from Northwest Regional Planning will be returning in June to discuss the proposed Municipal Town Plan revisions. He also mentioned removing outdated sections of the Town Plan associated with the Swanton Community Visit, and the formation of the Swanton Energy Commission and the Swanton Arts Council. Mr. Daniel also recommended implementing a Jaycee's chapter to Swanton which is a community service organization similar to the Swanton Chamber of Commerce to attract and retain businesses in the community of Swanton. Mr. Manning stressed the importance of community goals and their relevance with this evening's meeting with the DRB to revise existing bylaws.
