5. Cannabis Seminar

Mr. Daniel and Ms. Giroux participated in a Zoom cannabis seminar on Tuesday. The seminar was divided between growing, manufacturing, and approval of sales. The seminar primarily related to individual municipal votes approving the sale of cannabis. Growing and manufacturing is regulated by the State of Vermont.

Growing on a retail level is subject to regulations from the State, but any operation would be subject to the same types of permitting as any other commercial operation. Ms. Giroux added that the current bylaws limit the growth of cannabis for retail sale in light manufacturing/agricultural districts and in any other zoned district as a conditional use, with the exception of the Village in Swanton.

6. Municipal Plan Review

Mr. Savage and Ms. Brunswick have been exchanging edits on the RFP. The deadline to submit the RFP is June 1, 2022. Mr. Daniel asked if a copy could be sent to members of the Planning Commission for review before its submittal? Ms. Giroux said she would send out a copy once its available.
