Mr. Gilbert-Fuller suggested reviewing Middlebury, Hinesburg & Charlotte Vermont. These town have pulled their definitions from State statue, that way when a statute is updated, they don't need to amend their bylaws.

One of these example definitions the board reviewed were farm structures. Mr. Parent said he can update these to align with the State's definitions.
