Mr. Fournier added how Swanton's Town Meeting needs more coverage on the articles being placed before the taxpayers and open positions available. Mr. Guilmette said that it was disappointing how there were over 4,000 registered voters in Swanton, with a turnout of around 650 votes counted overall. Mr. Fournier then recommended mailing out ballots, to which Ms. Fournier interjected saying this upsets people and cited how the returned unfilled ballots costs the Town a lot of money.

Article 2: Shall the Town appropriate \$1,044,303.75 for the operation and maintenance of the Town Highway Department?

Article 3: Shall the Town appropriate \$263,875.00 for fire protection?

Article 4: Shall the Town appropriate \$157,239.94 to provide police protection to the residents of the Town of Swanton?

Article 5: Shall the Town appropriate \$333,925.92 for the Town General expenses? Article 6: Shall the Town appropriate \$194,097.00 towards the Operating and Maintenance Budget of the Swanton Public Library?

Article 7: Shall the Town appropriate an additional \$53,500.00 toward the Operating Budget of the Swanton Public Library?

Article 8: Shall the Town collect its real and personal property taxes to defray the expenses of the Town for the fiscal year commencing January 1, 2022, and annually thereafter, by its actual receipt of payment (postmarks will not be accepted) at the Town Offices by 5:00 p.m. on October 15th, or if the 15th shall fall on a weekend or holiday, the following business day by 5:00 p.m., with an eight percent (8%) penalty and one percent (1%) interest per month (or portion thereof) due thereon for the first three months, and one and one half percent (1.5%) per month (or portion thereof) thereafter, to be charged for late payment of any installment?

Article 9: Shall the Town appropriate \$196,628.00 to provide rescue services to the residents of the Town of Swanton?

Article 10: Shall the Town appropriate \$123,247.24 towards the Operating and Maintenance Budget of the Recreation Department?

- I. Economic Development Updates
 - a) ARPA Updates

Mr. Savage received correspondence recommending not spending any ARPA funds until after March 31st. The spending opportunities are flexible, but Mr. Savage recommended putting it out to the public on how the money should be spent beyond existing projects. Mr. Rocheleau recommended planning for the future, rather than spending the money right now, planning out five to ten years.

b) State Funding Proposal

Mr. Savage will be speaking with the Secretary of Agriculture to discuss opportunities. Mr. Fournier reiterated the importance of pushing projects forward like the sale of old cheese plant to Swann Valley.

- J. Highway Department
 - a) Updates (None)
 - b) Weight Permit

Mr. Guilmette said that a portion of the Frontage Road will be used to transport equipment weighing over 149,000 lbs. which exceeds the weight limit of that road. He said as long as the equipment is moved during a particular time of year, the road can handle the load.

Mr. Rocheleau made a motion to approve the Weight Permit up to May 1st, with conditions on the road being frozen or dried out, seconded by Ms. Draper. Motion carried.

- K. Any Other Necessary Business
 - a) Library Representative

With the Town taking over the Public Library, it is important to have a liaison on the board that can provide communication between the Library Board of Trustees and the Selectboard. A motion to appoint Mark Rocheleau as Library Commissioner was added to the List of Task Representatives.

b) Library Records

Mr. Fournier raised a concern about the Public Library keeping adequate records for financials and raises an issue of accountability. Mr. Guilmette mentioned that annual audits are a requirement for the past few years now.
