Members of the Selectboard briefly reviewed the Swanton Animal Control Officer monthly report.

#### 4. Old Town Business

a) Open Bids received for Swanton Public Library Heating System Replacement

Alliance Mechanical \$59,680.00 Allen's Green Mountain Plumbing and Heating Services \$38,945.00 Robinson Mechanical \$65,627.00

The bid received from Allen's Green Mountain Plumbing and Heating Services, LLC did not include labor. Mr. Guilmette mentioned that Alliance has had the service contract on the Library equipment for a number of years.

Mr. Bourgeois made a motion to accept Alliance Mechanical's bid, seconded by Mr. White. Motion carried.

## b) Recreation/Community Center Update – Joel Clark

Mr. Clark updated the Selectboard on communications with Cross Consulting Engineers. Mr. Clark expressed that there was a rise on cost due to engineering and design components. Mr. Clark expressed that this figure does not include funding for the physical construction work. Mr. Bourgeois asked about additional engineering firms outside Cross Consulting Engineers to bid on the project. Mr. Clark explained that it is simpler to retain the existing firm. Mr. Guilmette added that Cross Consulting has done for work for the Town in the past and added the complications of working with firms outside Franklin County. Continuing, once the design is in place, Mr. Clark added the procurement of funding through a bond vote to support the construction of the design.

Mr. Bourgeois asked about what consulting with the Selectboard would look like moving forward? Mr. Clark stressed the importance of going through the Recreation Department because this is their project and land but highlighted the important connection with the Selectboard. Mr. Bourgeois asked where the input came from for a community center. Mr. Clark explained that some of this feedback came from the revitalization of the Fourth Street Site. Ms. Fournier added that a community center came up during the community visit as well. Mr. Bourgeois recommended putting together studies on how the Recreation Department will fund the construction of the community center.

Mr. White made a motion for Mr. Savage to sign the contract with Peter Cross to continue with Cross Consulting Engineers for the preliminary design of the community center, seconded by Ms. Draper. Motion carried.

#### c) LVRT Trailhead Update – Joel Clark

Mr. Clark went through the forms needed for the project including the Project Commitment form. These forms would require Brian Savage as the full-time municipal employee to sign and authorize them. Mr. Clark asked about reimbursement for paper and ink expenses related to his involvement. Mr. Guilmette said this could be possible.

Ms. Draper made a motion for Mr. Savage to sign and authorize the grant agreement and subsequent forms, seconded by Mr. Bourgeois. Motion carried.
