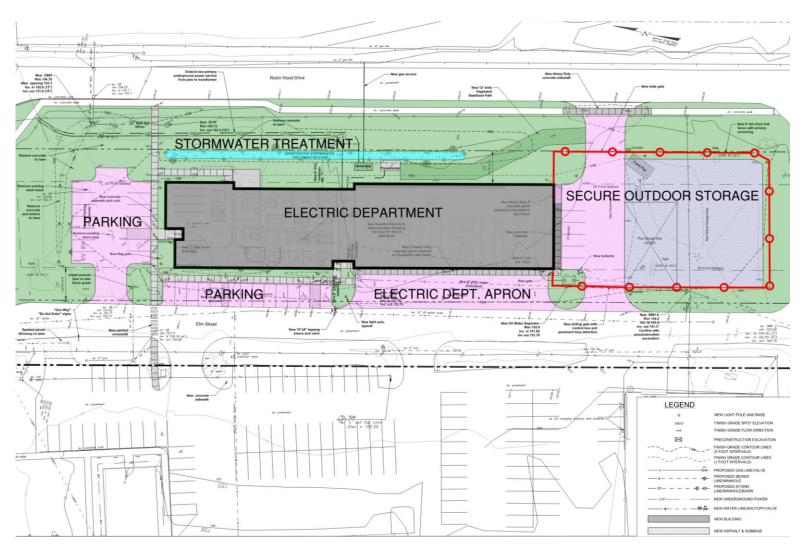






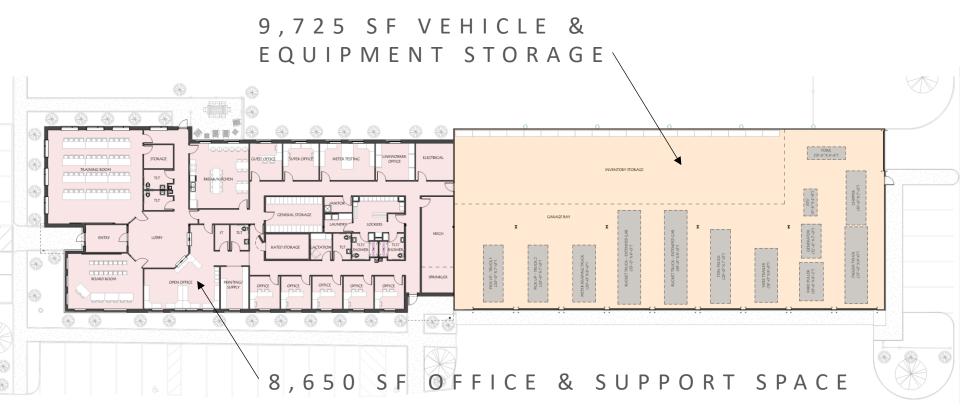
EXISTING AERIAL VIEW OF PROJECT SITE





PROPOSED PROJECT SITE PLAN

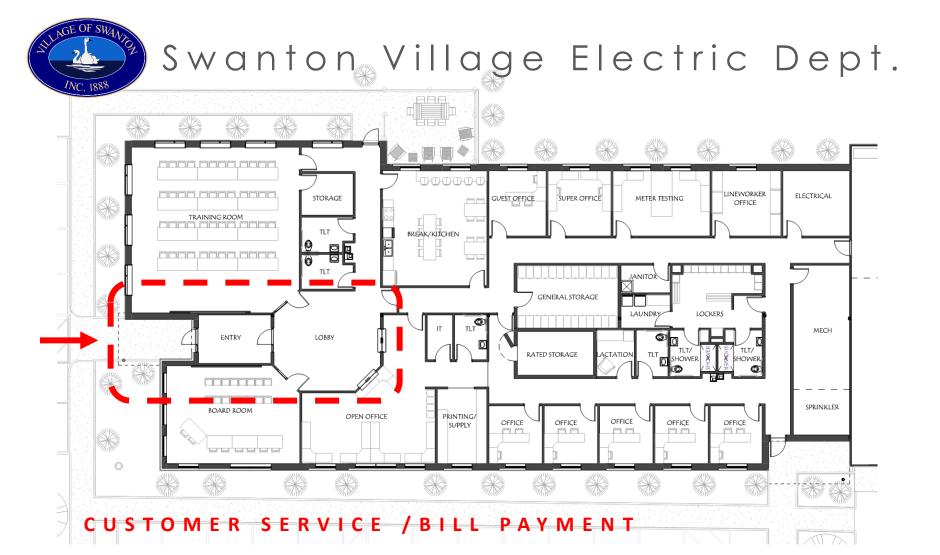


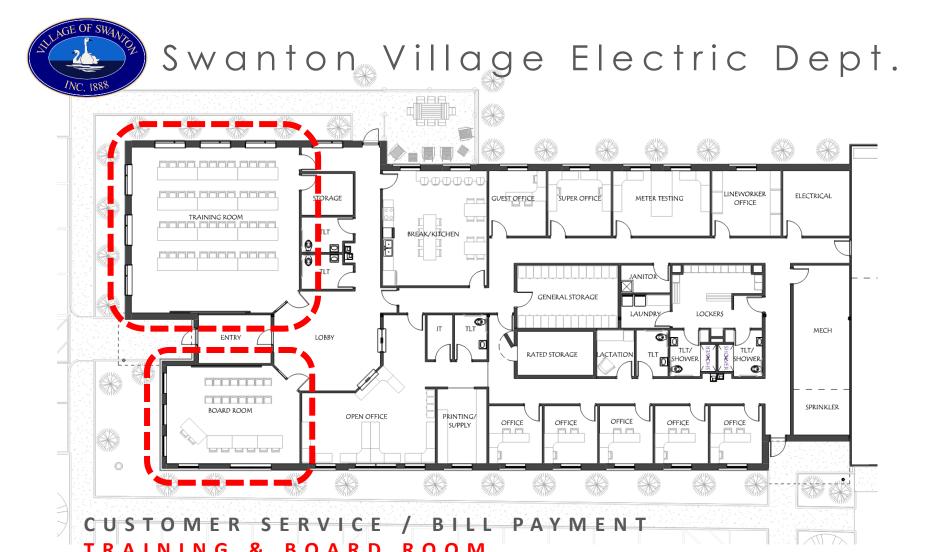

PROPOSED OVERALL FLOOR PLAN

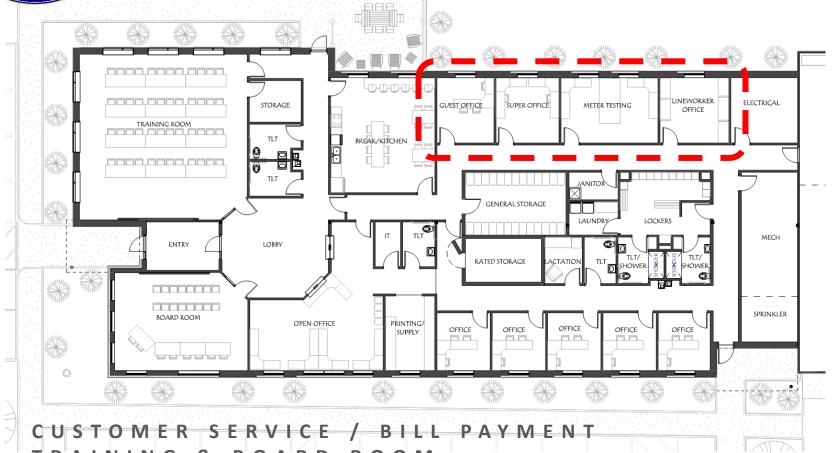

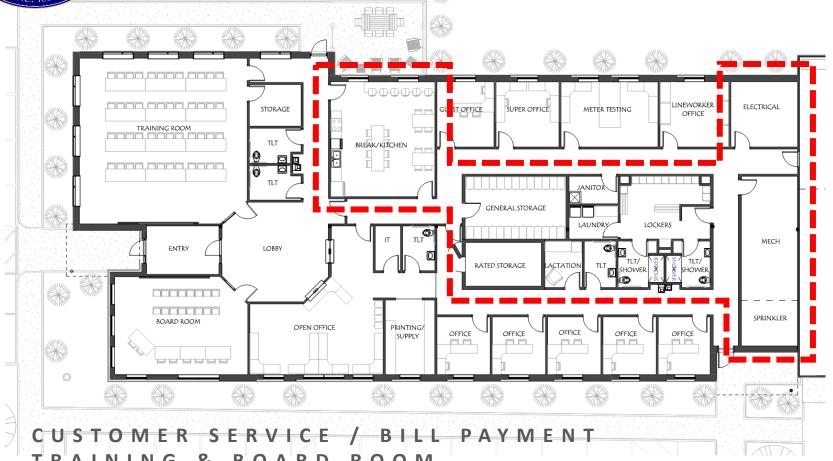

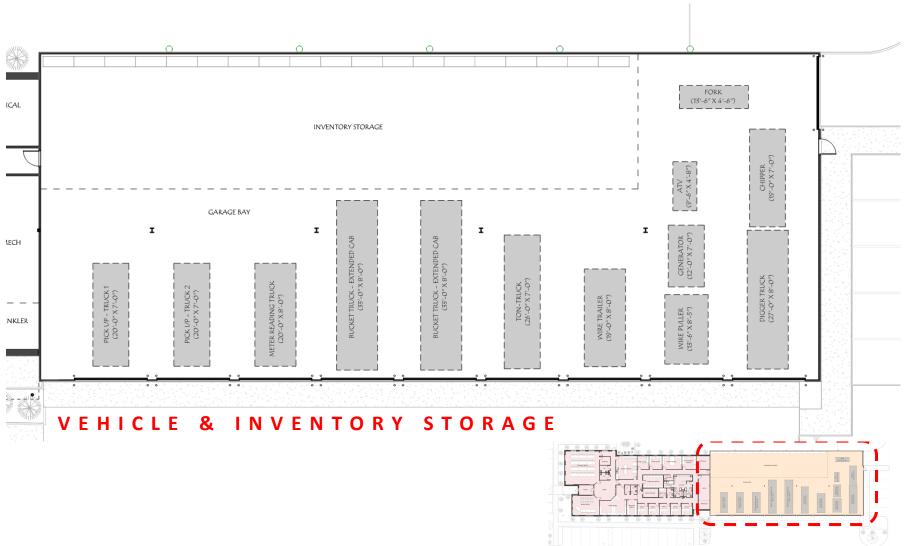
